FACILITIES

EACH STALL WILL HAVE THREE SIDE WALLS (WITH PLYWOOD PANELS) HELD BY PREFABRICATED ALUMINIUM SYSTEM WITH FASCIA (NAME IN ENGLISH) Max.25 LETTERS, 1 TABLE, 3 CHAIRS, 3 SPOTLIGHTS & ONE 5AMP POWERSOCKET. **IF BARE SPACE: NO CHAIR, TABLE, SPOTLIGHT & POWER SOCKET PROVIDED.**

PAVILION WILL HAVE BARE SPACE ONLY.

- Extra Tables, Chairs, Racks, Spot lights & Power Sockets shall be provided on request against payment.
- The organizers shall provide common security; however, the sole responsibility lies with the PARTICIPANT against any damage or loss of their exhibits.
- Persons participating in the exhibition are expected to behave in a manner that does not cause injury or damage or harm to any other person, exhibits, or to the property of the contractors and trade fair venue.
- Participants/Exhibitors shall display products/services related to CABLE TV & BROADBAND sector only in this TRADE SHOW. The organizers reserve the right to remove any product or services that are not related to CABLE TV & BROADBAND sector.
- Products causing loud noise, giving objectionable odour or inflammable in nature are not allowed. Food and drinks are not allowed inside the exhibition hall.
- Display of products and publicity material on stall fascia channel shall not be permitted.
- No nails or screws can be used on the partition boards/furniture in the stall. Drilling or making holes on partition boards/furniture is prohibited. The exhibitor will compensate for damage of any kind to the partition board/furniture. The maximum compensation shall be replacement cost of the same.
- The Stalls & Pavilions are not transferable and cannot be sub-let/shared.
- Exhibitors shall be solely liable for any statutory obligations such as GST, Way-bill, Excise duty, Trade License etc. on the products brought in the exhibition hall for display.
- All exhibitors must remove their entire materials and dismantle their stall/pavilion before 10 PM on the last day of the exhibition.
- The organizers may amend these terms and conditions and floor plan to suit the atmosphere and viability of the exhibition.
- Booking of space shall be confirmed in writing by the organisers only after receipt of full payment with the application form / Pro-forma Invoice
- Any PARTICIPANT from our previous trade fair with outstanding dues will not be granted space unless previous dues are cleared.
- The Trade Fair is meant for display only; sales are not allowed in the exhibition hall.
- Any Entertainment Programme by the PARTICIPANT will not be allowed inside the Exhibition Hall.

- Application for booking of space shall be made by the intending participants/exhibitors valid in all respect in the prescribed format in the APPLICATION FORM available at our Exhibition office. Specimen copy of the Application form can be viewed on our website www.ctmaindia.com Intending applicant can contact us to collect the Application form in person or through courier.
- Such application completes in all respects along with the monies payable as per PRO-FORMA INVOICE shall be deposited at our Exhibition Office during working days between 11am and 5 pm. and receipt obtained thereof.
- The applicant is required to make full payment of the category/space charges including applicable GST for consideration of allotment of the category/space applied to the successful applicant.
- Any application received without 100% payment of the total charges for the category/space applied including applicable GST and/or Incomplete Information in the APPLICATION FORM will be treated as invalid application and will be rejected outright without being considered for allotment.
- Allotment of space, subject to availability, will be the made to the successful applicant by the organizer and its decision shall be final in all respects.
- ALLOTMENT LRTTER will be issued after full payment has been received from the intending PARTICIPANT, Space will be handed over at the trade fair hall only to holders of the ALLOTMENT LETTER.
- Applicant/Participant desirous of deducting TDS will have to initially make full payment for allotment of category/space. They will be allowed to submit TDS certificate within 30 days of the end of the quarter in which payment has been made or 30th April, 2020 whichever is earlier. The amount equivalent to TDS Certificate will be refunded within 7 days of the receipt of the said TDS Certificate.
- Payment to be made by RTGS/NEFT or Demand Draft favouring "CABLE TV EQUIPMENTS TRADERS & MANUFACTURERS ASSOCIATION" payable at Kolkata.
- CTMA shall not recognize/entertain any precedent or preferential space allotment as a right to regular /repeat participants.

FORCE MAJEURE

The exhibition may be postponed /shortened due to any cause whatsoever beyond the control of the organisers. The organizers shall not be responsible for any loss sustained by the intending PARTICIPANTs directly or indirectly, attributable to the elements of nature, force majeure or orders and directives imposed by any Government Authority.
